Upon completion of this qualification, students are eligible to apply for roles such as:

- Childhood education manager
- Outside school hours coordinator

## IMPORTANT INFORMATION

### DURATION

This qualification is typically delivered over a minimum duration of 12-14 months, including 280 hours of work placement in a regulated childcare facility.

### DELIVERY

The training is conducted by a qualified, industry current, trainer and assessor to ensure the learning is relevant and up to date. This training will take place in a classroom environment using face-to-face training methods at one of our study locations. Intakes are scheduled throughout the year.

### ENTRY REQUIREMENTS

Entry to this qualification is open to individuals who hold either CHC30121 Certificate III in Early Childhood Education and Care or CHC30113 Certificate III in Early Childhood Education and Care. Students must also hold a valid Working with Children Check (WWC) or state equivalent, and have a police to attend Practical Placement. Students must also have current COVID-19 vaccinations.
