Educators at this level are responsible for designing and implementing curriculum that meets the requirements of an approved learning framework and for maintaining compliance in other areas of service operations.



This qualification is typically delivered over a minimum duration of 12-14 months, including 280 hours of work placement in a regulated childcare facility.



Upon completion of this qualification, students are eligible to apply for roles such as:

- Childhood education manager
- Outside school hours coordinator



The delivery location of this qualification will vary based on student's employment location.

DURATION

Students must also hold a valid Working with Children Check (WWC) or state equivalent, and have a police to attend Practical Placement.
