

COURSE

Work involves implementing community based programs and activities focusing on mental health, mental illness and psychiatric disability. Work is undertaken in a range of community contexts such as community based non-government organisations; home based outreach; centre-based programs; respite care; residential services, rehabilitation programs; clinical settings; or supporting people in employment. Work is carried out autonomously under the broad guidance of other practitioners and professionals.

IMPORTANT INFORMATION

DURATION

This qualification is typically delivered over a minimum duration of 7.5 months, including 80 hours of work placement in a mental health work setting.

DELIVERY

The training is conducted by a qualified, industry current, trainer and assessor to ensure the learning is relevant and up to date. This training will take place in a classroom environment using face-to-face training methods at one of our study locations. Intakes are scheduled throughout the year.

ENTRY REQUIREMENTS

There are no formal entry requirements for this qualification, although applicants will need to undertake an LLN assessment. Students are required to complete a Practical Placement which requires a police check and a NDIS screening. Students must also have current COVID-19 vaccinations.

Upon completion, students could go further with their study with our CHC52021 - Diploma of Community Services.
