DURATION

This qualification is typically delivered over a minimum duration of 15 months, including 120 hours of work placement.

DELIVERY

The training is conducted by a qualified, industry current, trainer and assessor to ensure the learning is relevant and up to date. This training will take place in a classroom environment using face-to-face training methods at one of our study locations. Intakes are scheduled throughout the year.

ENTRY REQUIREMENTS

There are no formal entry requirements for this qualification, although applicants will need to undertake an LLN assessment. Students are required to complete a Practical Placement which requires a police check and a NDIS screening. Students must also hold a valid Working with Children Check (WWC) or state equivalent. Students must also have current COVID-19 vaccinations.

Upon completion, students could go further with their study with our CHC43015 - Certificate IV in Ageing Support.
